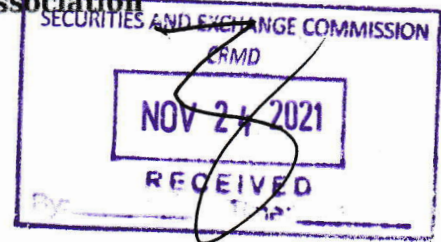




Articles of Incorporation
of
**MFI Polytechnic Institute Alumni Association
Inc.**



KNOW ALL MEN BY THESE PRESENTS:

The undersigned incorporators, all of legal age and majority of whom are residents of the Philippines, have this day voluntarily agreed to form a non-stock corporation under the laws of the Republic of the Philippines.

AND WE HEREBY CERTIFY:

First: That the name of said corporation shall be

MFI Polytechnic Institute Alumni Association Inc.

Second: That the purpose or purposes for which such corporation is incorporated are:

The main purpose of the Association is to support the mission-vision of MFI Polytechnic Institute. The Association has the following objectives: Section 1 To establish, organize and maintain the spirit of camaraderie and cooperation among the alumni of the MFI Polytechnic Institute in order to preserve their bond and brotherhood; foster closer relationship among themselves and improve their individual and collective welfare. Section 2 Promote and undertake projects and activities designed to enhance their cultural, social and economic well-being and to continue to uphold the noble tradition, ideals and causes for which the MFI Polytechnic Institute stand for and safeguard its good name and reputation as defender of our democratic way of life. Section 3 Assist and participate in any manner in the programs and undertakings of the alumni association, the school as well as that of the government ;

Provided that the corporation shall not solicit, accept or take investments/placements from the public neither shall it issue investment contracts.

Third: That the principal office of the corporation is located in **MFI POLYTECHNIC BUILDING ORTIGAS AVENUE UGONG DISTRICT 1, CITY OF PASIG, SECOND DISTRICT, NATIONAL CAPITAL REGION (NCR), 1605;**

Fourth: That the corporation shall have a term of existence of **fifty (50) years**



from the date of issuance of the certificate of incorporation;

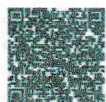

Seventh: That the total contribution of the corporations is Nine Thousand Pesos (P9,000).



Eighth: That FERNANDO ACOGEDO SANTIAGO has been elected by the members as Treasurer of the corporation to act as such until his successor is duly elected and qualified in accordance with the by-laws, and that as such Treasurer, he has been authorized to receive for and in the name and for the benefit of the corporation, all contributions or donations paid or given by the members.

Ninth: That no part of its income is distributable as dividends to its members, trustees or officers subject to the provisions of the Corporation Code of the Philippines on dissolution. Provided, that any profit obtained by the association as an incident to its operation shall, whenever necessary or proper shall be used for the furtherance of the purposes enumerated in Article II, subject to the provision of Title XI of the Corporation Code of the Philippines.

Tenth: That no member of the Board of Trustees shall receive any compensation or remuneration in cash or in kind for services rendered to the corporation as members.

Eleventh: That the level of administrative expenses of the corporation shall not, on an annual basis, exceed thirty percent (30%) of the total donations received and total expenses for the taxable year.

Twelveth: That in the event of dissolution, the assets of the corporation shall be distributed to another corporation, organization or association whose purpose/purposes are similar to the purpose/purposes of the dissolved corporation, or to the State for public purpose/purposes, or shall be distributed in accordance with an Order issued by a court of competent jurisdiction.

Thirteenth: That the incorporators undertake to change the name of the corporation immediately upon receipt of notice from the Commission that another corporation, partnership or person has acquired a prior right to the use of such name, that the name has been declared not distinguishable from a name already registered or reserved for the use of another corporation, or that it is contrary to law, public morals, good customs or public policy.


